

The Florida League of Cities' Legislative Action Days will be held **March 21-22, 2017**, in Tallahassee. Hotel space is limited in Tallahassee during session, so make your travel plans now!

Be part of this year's advocacy efforts as President Susan Haynie and the League's legislative team strategize and prepare for this critical session. You'll hear directly from key legislators on an array of important issues.

The event begins on **Tuesday, March 21**, with a legislative briefing at 10:00 a.m. in Sittig Hall, located at the FLC office, followed by a legislative luncheon from 11:45 a.m. until 1:30 p.m. at the Doubletree Hotel. Learn the latest on key issues affecting municipalities. After lunch, plan to visit the Capitol for scheduled meetings with your legislators. League staff will work with regional leagues to coordinate and schedule appointments. **Please be sure to indicate your local/regional league on the registration form below.**
