

## Summary of January 29, 2024, FLC Morning Call-In

### Charles Chapman Update:

- [HJR 7017](#) (Buchanan) **Annual Adjustment to Homestead Exemption Value – Oppose** – HJR 7017 is on the House Special Order Calendar (House Floor) on Thursday, February 1. The implementing bill, [HB 7019](#) (Buchanan), is also on the February 1 House Special Order Calendar. There are no Senate companion bills.
- [HB 609](#) (Botana) and [SB 1144](#) (DiCeglie) **Local Business Taxes – Oppose** – HB 609 has three committee references in the House and has not yet been heard in a committee. SB 1144 also has three committee references and has not yet been heard in a committee.
- [HB 1195](#) (Garrison) and [SB 1322](#) (Ingoglia) **Millage Rates/Supermajority Vote – Oppose** – The next committee stop for HB 1195 is the House Local Administration, Federal Affairs & Special District Subcommittee. This is the second of three committee stops in the House. The next stop for SB 1322 is the Senate Fiscal Policy Committee. This is the second of three committee stops in the Senate.

### David Cruz Update:

- [SB 472](#) (Brodeur) and [HB 569](#) (McFarland) **Suits Against the Government/Sovereign Immunity – Oppose** – SB 472 will be heard today, January 29, at 1:30 p.m. in the Senate Governmental Oversight and Accountability Committee. This meeting will be in 301 Senate Office Building. This is the first of three committee stops in the Senate. HB 569 has two more committee stops in the House. The next stop is the House Appropriations Committee.
- [HB 479](#) (W. Robinson) and [SB 688](#) (Martin) **Alternative Mobility Funding Systems – Support** – HB 479 will be heard on Tuesday, January 30, at 10:00 a.m. in the Commerce Committee held in 212 Knott Building. This is the final committee stop in the House. SB 688 will be heard on Tuesday, January 30, at 1:00 p.m. in the Transportation Committee held in 110 Senate Office Building.

### Jeff Branch Update:

- [SB 328](#) (Calatayud) and [HB 1239](#) (V. Lopez) **Affordable Housing/Live Local – Support** – SB 328 will be heard on Wednesday, January 31 at 9:00 a.m. in the Fiscal Policy Committee held in 110 Senate Office Building. This is the final committee stop in the Senate. HB 1239 has three committee references and has not yet been heard in a committee.

### Rebecca O’Hara Update:

- [SB 1628](#) (Collins) and [HB 1547](#) (McClure) **Local Government Actions – OPPOSE** – SB 1628 will be heard on January 29 at 1:30 p.m. in the Community Affairs Committee held in 401 Senate Office Building. This is the first of two committee stops in the Senate. HB 1547 has three committee stops in the House and has not yet been heard in a committee.
- **WST1** (Water Quality, Supply and Treatment Subcommittee) and [PCB 7040](#) (Environment and Natural Resources) **Ratification of the Department of Environmental Protection’s Rules Relating to Stormwater – Support** – WST1 will be heard today, January 29 at 3:00 p.m. in the House Water Quality, Supply and Treatment Subcommittee held in 404 House Office Building.

The Senate companion bill, SB 7040, passed its first committee of reference last week and has two more committee stops in the Senate.

- [HB 972](#) (Trabulsky) and [SB 770](#) (Martin) **Improvements to Real Property/PACE – Support** – HB 972 will be heard on Tuesday, January 30 at 3:00 p.m. in the House Energy, Communications and Cybersecurity Subcommittee in 102 House Office Building. This is the first of three committee stops in the House. SB 770 will be heard on Wednesday, January 31, at 9:00 a.m. in the Senate Fiscal Policy Committee. This is the final committee stop in the Senate.
- We will know by 4:30 p.m. today if the two utility bills, [HB 777](#) (Brackett) **Water and Wastewater Surcharge** and [HB 1277](#) (Busatta Cabrera) **Enterprise Fund Transfers**, will be heard in the Local Administration, Federal Affairs and Special Districts Subcommittee this week. The League is **opposed** to both bills.

#### Sam Wagoner Update:

- [SB 658](#) (DiCeglie) and [HB 473](#) (Giallombardo) **Cybersecurity Incident Liability – Support** – SB 658 will be heard today, January 29, at 4:00 p.m. in the Senate Judiciary Committee held in 412 Knott Building. This is the first of three committee stops in the Senate. HB 473 passed out of its first committee of reference and has two more committee stops in the House.
- [HB 1537](#) (Griffitts) and [SB 280](#) (DiCeglie) **Vacation Rentals – Oppose** – The next stop for SB 280 is the Senate Floor/Special Order Calendar. The next stop for HB 1537 is the House Regulatory Reform & Economic Development Subcommittee. We will know by 4:30 p.m. today if HB 1537 is on the February 1 Committee agenda.
