

## ORDINANCE

## 5624

AN ORDINANCE OF THE CITY OF BOCA RATON AMENDING CHAPTER 9, "MISCELLANEOUS OFFENSES," CODE OF ORDINANCES, ARTICLE I, "IN GENERAL," BY CREATING SECTION 9-7, "PROHIBITION OF SMOKING IN PARKS AND ON BEACHES OWNED BY THE CITY," CODE "SUPPLEMENTAL ARTICLE IV, AMENDING SECTION 9-60. PROCEDURES," ENFORCEMENT "SUPPLEMENTAL CODE ENFORCEMENT PROCEDURES," TO INCLUDE SECTION 9-6 (REGULATION OF ELECTRONIC CIGARETTES) AND SECTION 9-7, (PROHIBITION OF SMOKING IN PARKS AND ON BEACHES OWNED BY THE CITY) TO ALLOW FOR ENFORCEMENT; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEALER; PROVIDING FOR CODIFICATION; PROVIDING AN EFFECTIVE DATE

WHEREAS, the Florida Clean Indoor Air Act, Section 386.209, Florida Statutes (the "Act"), which regulates where smoking is permitted, was recently amended to be renamed the "Florida Clean Air Act," and was also amended to authorize municipalities and counties to restrict

smoking (with the exception of unfiltered cigars) in public parks and on public beaches they own; and

WHEREAS, based on the legislative amendment, the City desires to amend its Code of Ordinances to add a prohibition on smoking in parks and on beaches owned by the City in order to protect the public from the potential health hazards associated with exposure to secondhand smoke; and

WHEREAS, the City Council finds that a prohibition of smoking in parks and on beaches owned by the city has a narrow, limited purpose that is consistent with the Act in order to protect individuals from the possibility of unwanted exposure to secondhand tobacco smoke; and

WHEREAS, the City Council desires to amend Section 9-60(2) of the Code of Ordinances to add Section 9-6, "Regulation of electronic cigarettes in a similar manner as tobacco cigarettes" and Section 9-7, "Prohibition of smoking in parks and on beaches owned by the city;" to allow for enforcement under that subsection; now therefore

THE CITY OF BOCA RATON HEREBY ORDAINS:

Section 1. Chapter 9, "Miscellaneous Offenses," Article I, "In General," Section 9-7, "Prohibition of smoking in parks and on beaches in parks and beaches owned by the city," is created to read:

Section 9-7. Prohibition of smoking in parks and on beaches owned by the city.

(1) Smoking Prohibited.

- No smoking shall be permitted in parks and on beaches owned by the city. (a)
  - (b) The above prohibition shall not apply to unfiltered cigars.

(2) Penalty. Any person who violates this section shall be subject to a civil penalty not 24 exceeding \$500; violation of this section shall not be punishable by imprisonment.

19	invalid, the remainder shall not be affected by such invalidity.
20	Section 4. All ordinances and resolutions or parts of ordinances and resolutions and
21	all sections and parts of sections in conflict herewith shall be and hereby are repealed.
22	Section 5. Codification of this ordinance in the City Code of Ordinances is hereby
23	authorized and directed.
24	Section 6. This ordinance shall take effect immediately upon adoption.
