

Summary of February 5, 2024, FLC Morning Call-In

Charles Chapman Update:

- [HJR 7017](#) (Buchanan) **Annual Adjustment to Homestead Exemption Value – Oppose** – HJR 7017 passed the full House (86-29) on February 1. The implementing bill, [HB 7019](#) (Buchanan), also passed the House floor and awaits action by the Senate. At this time, there are no Senate companion bills.
- [HB 609](#) (Botana) and [SB 1144](#) (DiCeglie) **Local Business Taxes – Oppose** – HB 609 has one more committee stop in the House, the House State Affairs Committee. We will know by 4:30 p.m. today if HB 609 is on the committee's February 7 agenda. SB 1144 has not been heard in any committee.
- [HB 1195](#) (Garrison) and [SB 1322](#) (Ingoglia) **Millage Rates/Supermajority Vote – Oppose** – The next and final committee stop for HB 1195 is the House State Affairs Committee. We will know by 4:30 p.m. today if HB 1195 is on the committee's February 7 agenda. The next stop for SB 1322 is the Senate Finance and Tax Committee. This is the second of three committee stops in the Senate. We will know by 2:30 p.m. today if SB 1322 will be on the committee's February 8 agenda.

David Cruz Update:

- [HB 479](#) (W. Robinson) and [SB 688](#) (Martin) **Alternative Mobility Funding Systems – Support** – HB 479 has passed all of its committees of reference and now heads to the House floor for consideration. The next and final committee stop for SB 688 is the Senate Rules Committee. We will know by 2:30 p.m. today if SB 688 is on the committee's February 8 agenda.
- [SB 472](#) (Brodeur) and [HB 569](#) (McFarland) **Suits Against the Government/Sovereign Immunity – Oppose** – The next committee stop for SB 472 is the Senate Appropriations Committee. The Senate Appropriations Committee is not scheduled to meet this week. HB 569 has one more committee stop in the House, the House Judiciary Committee. We will know by 4:30 p.m. today if HB 569 is on the committee's February 7 agenda.

Jeff Branch Update:

- [SB 684](#) (DiCeglie) and [HB 267](#) (Esposito) **Residential Building Permits – Oppose** – SB 684 will be heard on Tuesday, February 6, at 3:00 p.m. in the Senate Community Affairs Committee. This is the first of three committee stops in the Senate. HB 267 has one more committee stop in the Senate, the Senate Commerce Committee. We will know by 4:30 p.m. today if HB 267 is on the committee's February 8 agenda.

Rebecca O'Hara Update:

- [SB 734](#) (Ingoglia) and [HB 735](#) (Andrade) **Government Accountability – Monitoring** – SB 734 will be heard today, February 5, at 2:30 p.m. in the Senate Ethics and Elections Committee. This is the second of three committee stops in the Senate. HB 735 has one more committee stop, the House State Affairs Committee. We will know by 4:30 p.m. today if HB 725 is on the committee's agenda.

- [SB 1628](#) (Collins) and [HB 1547](#) (McClure) **Local Government Actions** – **Oppose** – SB 1628 will be heard on February 6 at 3:00 p.m. in the Community Affairs Committee. This is the first of two committee stops in the Senate. HB 1547 has three committee stops in the House.
- [SB 770](#) (Martin) and [HB 972](#) (Trabulsy) **Improvements to Real Property/PACE** – **Support** – SB 770 passed both committees of reference and is on the February 7 Senate Special Order Calendar. The next stop for HB 972 is the House Ways and Means Committee. We will know by 4:30 p.m. on February 6 if HB 972 will be on the February 8 agenda.
- [HB 1277](#) (Busatta Cabrera) and [SB 1510](#) (Brodeur) **Enterprise Fund Transfers** – **Oppose** – The next and final committee stop for HB 1277 is the House Commerce Committee. We will know by 4:30 p.m. on February 6 if HB 1277 will be on the February 8 agenda. SB 1510 has three committee references.

Sam Wagoner Update:

- [HB 473](#) (Giallombardo) and [SB 658](#) (DiCeglie) **Cybersecurity Incident Liability** – **Support** – HB 473 will be heard on Tuesday, February 6 at 11:30 a.m. in the House State Administration & Technology Appropriations Subcommittee. This is the second of three committee stops in the House. SB 658 will be heard on Tuesday, February 6, at 3:00 p.m. in the Senate Governmental Oversight and Accountability Committee. This is the second of three committee stops in the Senate.
- [HB 1537](#) (Griffitts) and [SB 280](#) (DiCeglie) **Vacation Rentals** – **Oppose** – HB 1537 passed out of its first committee last week. The next committee stop is the House Ways and Means Committee. We will find out on February 6 if HB 1537 is on the committee's February 8 agenda. SB 280 passed the full Senate (27-13) on February 1.
- [HB 1365](#) (Garrison) and [SB 1530](#) (Martin) **Unauthorized Public Camping and Public Sleeping – Monitoring** – SB 1530 will be heard today, February 5, at 2:30 p.m. in the Senate Judiciary Committee. This is the second of three committee stops in the Senate. HB 1365 has two more committee stops: the Judiciary Committee and the Health and Human Services Committee.
