Charles Chapman Update:

- HB 1195 (Garrison) and SB 1322 (Ingoglia) Millage Rates/Supermajority Vote Oppose HB 1195 will be heard today, January 22, at noon in the House Ways & Means Committee. This is the first of three committee stops in the House. SB 1322 will also be heard today, January 22, at 4:00 p.m. in the Senate Community Affairs Committee. This is the first of three committee stops in the Senate.
- HJR 7017 (Buchanan) Annual Adjustment to Homestead Exemption Value Oppose HJR 7017 will be heard on Tuesday, January 23, at 10:00 a.m. in the House State Affairs Committee. This is the final committee stop in the House. There is no Senate companion bill.

 Committee. This is the first of three committee stops in the Senate. HB 1647 has three
 committee references and has not yet been heard in a committee.
- <u>SB 688</u> (Martin) and <u>HB 479</u> (W. Robinson) Alternative Mobility Funding Systems Support –
 Neither bill will be heard this week. SB 688 has two more committee stops in the Senate, and HB
 479 has one more committee stop in the House.
- HB 569 (McFarland) and SB 472 (Brodeur) Suits Against the Government/Sovereign Immunity –
 Oppose Neither bill will be heard this week in a committee. HB 569 has two more committee
 stops in the House, and SB 472 has three stops in the Senate.

The next committee meeting is scheduled for Wednesday, January 24 at 8:00 a.m. We will know by 4:30 p.m. today if HB 1537 will be on the committee agenda. The next stop for SB 280 is the Senate Floor.
